## **Coaches –**

Unable do two clinics in on year. If you have a brand new coach that has never coached before can coach at Bantam and above because there is no clinic

Coaches that did not attend the clinic last year but were on form 100 are not allowed on the bench until they take a clinic

## **Officials –**
